The Provision of the New Logo to Medical, Paramedical, Medical Aid Services**

Senior Minister and Minister of Health

- Having seen the Constitution of Cambodia;
- Having seen Royal Decree No. NS/RKT/1998 dated 30 Nov1998 on the Appointment of the Royal Government of Cambodia;
- Having seen Royal Kram No. NS/RKM/0196/06 dated 24 Nov1996 promulgating the Law on the Establishment of Ministry of Health;
- Having seen Sub Decree No. 67 ANKr-KT dated 22 Oct 97 on the Organization and Functioning of the Ministry of Health;
- Having seen Royal Kram No. NS/RKM/1100/10 dated 03 Nov 2000 promulgating the Law on the Management of Private Medical, Paramedical and Medical Aid Profession; and
- With reference to the necessary requirements of the Ministry of Health;

Hereby Decides

Article 1

In order to enhance the implementation of the technical standards at the Private Medical, Paramedical and Medical Aid services and as the motivation to private medical, paramedical and medical aids services, Ministry of Health will provide a new logo to any private Medical, Paramedical and Medical Aid services which have complied with the Ministry of Health's instructions.

Article 2

The new logos for polyclinics, specialized clinics, and obstetric clinics are of the following features:

- A plastic board of 60 cm x 60 cm encircled by blue lines of 0.5 cm in width,
- This plastic board is divided into two parts:
 - a. The upper part of 40 cm x 16 cm is made up of dark yellow color with the dark blue writing:
The authorization letter from Ministry (3 cm in height)

No:.....ABS-MP Dated.....(2 cm in height)

- b. The lower part of 44 cm x 40 cm made up of white color consists of the white cross sign in the middle surface. Each corner is made up of 10 cm in length encircled by dark blue lines of 0.5 cm in width.
- In the middle of the cross sign there is a stick surrounded by a dark blue snake. The stick is made up of 26 cm in height with its head of 3 cm in length.

Article 3

The new logo for treatment cabinet, dental cabinet, physiotherapy cabinet, nursing cabinet, ANC cabinet, aesthetic cabinet, and medical laboratory are of the following features:

- A plastic board of 45 cm x 35 cm encircled by dark blue lines of 0.8 cm in width,
- Plastic board is divided into two parts:
 - a. The upper part of 35 cm x 11 cm is made up of dark yellow color with the dark blue writings:
The authorization letter from Ministry (2.5 cm in height) No:.....ABS-MP Dated.....(1.5 cm in height)
 - b. The lower part of 35 cm x 34 cm made up of white color consists of the white cross sign in the middle surface. Each corner is made up of 9 cm in length encircled by dark blue lines of 0.5 cm in width.
- In the middle of the cross sign there is a stick surrounded by a dark blue snake. The stick is made up of 23 cm in height with its head of 2 cm in length.

Article 4

The private medical, paramedical and medical aid services which have already obtained the new logos from Ministry of Health, shall endeavor to continuously implement these standards and Ministry of Health's instructions in an effective manner. In case of non-compliance with the instructions, Ministry of Health is entitled to seize the new logo automatically

Article 5

Any person who intentionally or unintentionally falsifies this new logo of the Ministry of Health as set out in Articles 2 and 3 shall be punishable in accordance with the existing laws.

Article 6

The Directorate General for Health, the Directorate General for Admin and Finance, the Directorate General for Inspection of Ministry of Health, the Hospital Department of Ministry of Health, Municipal and Provincial Health Departments, the relevant private medical, paramedical and medical aid services shall implement this Prakas in a highly effective manner.

Article 7

This Prakas is effective from the date of signing hereafter.
